

A&L PRIVACY NOTICE FOR CLIENTS

In accordance with the Federal Law on the Protection of Personal Data in Possession of Private Parties, we hereby issue this Privacy Notice with the following terms:

▪ RESPONSIBLE FOR PERSONAL DATA

Pursuant to this Privacy Notice, AROCHI & LINDNER, S.C. (**A&L**), is responsible for the protection and use of your personal data. A&L can be contacted by email at datospersonales@arochilindner.com, or at its office located at Insurgentes Sur 1605, Piso 20, Colonia San José Insurgentes, C.P. 03900, México, D.F.

▪ PRIMARY PURPOSES

Unless the owner of said data objects to such use as described in this Privacy Notice, personal information we may need to collect shall be used and protected under strict confidentiality by **A&L** and will be used to issue reports and legal opinions; receive or send instructions related to national and international legal procedures, to perform administrative acts before authorities, provide legal representation in administrative and judicial litigations, carry out administrative and judicial measures necessary to defend your interests, issue receipts and make payments, and finally, maintain records in our database.

▪ SECONDARY PURPOSES

You may consent to A&L using your personal data for secondary purposes such as sending news bulletins and invitations to events organized by the firm.

I do NOT consent to the use of my personal data for secondary purposes.

▪ PERSONAL DATA

We shall collect personal data as to the name, tax address, employment address, phone, email, tax ID number, and population registry (CURP).

▪ TRANSFER

We inform you that we share your personal data with different firms specializing in Intellectual Property, and other authorities outside of Mexico in order to carry out administrative procedures and litigations with the purpose of protecting and defending your Intellectual Property rights.

▪ RIGHTS TO ACCESS, CORRECITON, CANCELATION AND OPPOSITION (ACCO)

You have the right to know which personal data we have, what purposes we are using it for, and the conditions of use we apply to it (Access). Moreover, you have the right to request correction of your personal data if it is out of date, incorrect or incomplete (Correction); to request that we eliminate it from our records or data bases if you consider that the data is not being used according to the principles, responsibilities and obligations set forth in the guidelines (Cancelation); as well as the right to oppose the use of your personal data for specific purposes (Opposition). These rights are known as ACCO rights.

The mechanisms in place for exercising said rights are outlined in the form attached to this Notice. The form can be emailed to datospersonales@arochilindner.com

A&L will get in touch with you at the latest in twenty business days counting from the date it receives the application for Access, Correction, Cancellation and Opposition to inform you of our decision. If we reach a decision to honor your request, we will apply it within fifteen business days following our response.

▪ **REVOKING CONSENT FOR USE OF PERSONAL DATA**

At any moment in time, you may revoke previously granted consent to use your personal data for the aforementioned secondary purposes, so that we will cease using your personal data. To this end, you must provide us with written notice as provided and attached to this Notice and send it electronically to datospersonales@arochilindner.com.

Nevertheless, it is important to note that we cannot always process your request or immediately cease using your data in every case, as we may need to continue using your personal data to fulfill legal obligations.

We will respond to your request no later than twenty business days following receipt of your request and inform you of our decision regarding your request.

▪ **CHANGES TO PRIVACY NOTICE**

We reserve the right to change or update this Privacy Notice in accordance with legislative updates, internal policies, or new requirements established for providing or lending our services.

These changes shall be made available by the following means:

- a. Visible notifications at our office.
- b. On our web page www.arochilindner.com under Privacy Notice.
- c. Otherwise, we will send notification to the last email address you have provided us.

▪ **MISUSE OF YOUR PERSONAL DATA**

If you feel that your right to personal data protection has been violated by any misconduct on the part of A&L, or in terms of any of its actions or responses, or suspect in the handling of your personal data a violation of any of the statutes in the Federal Law on the Protection of Personal Data in Possession of Private Parties may have occurred, you may file a complaint or press charges at the National Institute of Transparency, Information Access and Personal Data Protection (INAI by its Spanish acronym).

Once the request has been received by A&L, we will respond within 20 (twenty) business days after the receipt of the corresponding application. Once the response has been sent, you will have a 15 (fifteen) day deadline to verify whether your right(s) have been enforced. In the event that you do not agree with the outcome of the response, you may contact the national transparency, information access, and personal data protection institute (INAI) www.inai.org.mx

All data you provide in the form shall be for the exclusive use of response and follow-up to your ACCO rights request.
